## REGULATIONS GOVERNING THE " SHOW OF EXCHANGES " ORGANIZED BY AGRI COLL ASSOCIATION

**Article 1 :** Demonstrations organized by A.C.A. in form of show of exchanges, have as the only purpose to favour transactions and contacts between collectors of miniatures and objects having **as topics agriculture, forestry and public works machine.**

**Article 2 :** The organizers save right to refuse any candidacy or to turn away every exhibitor who would infringe the present regulations or who would not respect places and equipment put at his/her disposal. In that case, he will be able to be claimed by refund nor of indemnity of no goes out.

**Article 3 :** A.C.A would not know how to be kept representative for thefts, deteriorations or breaking made in places receiving the show. The exhibitors are responsible for damage caused in the put at their disposal equipments and will have to leave their stand in the best state of cleanness.

**Article 4 :** The displayed objects reside under the supervision of their owners, at their risks and dangers. The organizers will not be able to be kept for representatives in case of loss, breakage, theft or other deterioration, whatever is haphazard or major reason. They decline any responsibility in the event of accident of persons caused by displayed objects, their handling, their installations, the use of electric current or for quite other reason before, hanging and after exhibition. The professional exhibitors will have to sign insurance necessary for their coverage.

**Article 5 :** No appeal will be able to be exercised against A.C.A. or his leaders, in case of acts of violence perpetrated during the grant by every person under the influence of alcohol or under quite other substance. The organizers will be able to decide on the ousting of whoever, which whatever means it is, shall fluster the good sequence of demonstration. In that case, he will be able to be claimed by refund nor of indemnity of no kind.

**Article 6 :** Every object offered in sale will have to include a marking pointing out its price. In case of bone of contention between sellers and purchasers, the leaders of A.C.A ., in one worries of impartiality, will return no arbitration and show a complete neutrality. They also say that, whatever is the nature of conflict, none of the opposite parties will be authorized to use what's new. nor to demand his support.

**Article 7 :** A.C.A. decline any responsibility in case of litigation d ' an exhibitor with the services of police, or collectivity.

**Article 8 :** **It is officially forbidden to add tables or to change the length and the form of presentation without the prior agreement of the organizers.**

**Article 9 :** Any not occupied stand one ½ the frank hour before opening door to the public, will be able to be again rented without it can be made claim . In case of major force, duly justified, the half of the performed remittance will be reimbursed.

**Article 10 :** Any incomplete newsletter of reservation, not accompanied with its regulations by check in order of A. C. A, or not signed will not be taken into account

**Article 11 :** A preferential rate on the price of the metre of table will be granted to the members of the association in day of contribution for ongoing year.

**Article 12 :** Before any sharing out of sites, the granted tables à gracious title in clubs and associations having an agreement with A.C.A ., will be allocated first and foremost.

**Article 13 :** Sites are rented by numerous of linear metre. No reservation of less than 2 meters will be accepted.

**Article 14 :** In expiry date of the period of tenancy, if request is superior to the capacity of reception, the following rule will be applied:  
- no stand will be able to exceed a number of metres fixed by the organizers for the circumstance.  
- sites will be allocated first and foremost to the members of the association.

**Article 15 :** After deadline fixed for reservations, sites free steps allocated in order of arrival of requests.

**Article 16 :** **It is forbidden to share and/or to sublease party or entirety of a site.** The only person who must be present on the stand and are able to prove their identity when requested

**Article 17 :** Miniatures and introduced objects not her on, sheets of paper or simply in exhibition will have to have a direct report with topics represented in the article 1.

**Article 18 :** The exhibitors promise to offer in sale or in exchange a quantity of models corresponding to the size of their sites. **They will be able to pack up again and leave their sites only at the earliest at 16 h 30. The not respect for this timetable will be able to draw away expulsion for next year.**

**Article 19 :** The reservation of sites will become written on the newsletter inscription envisaged with this effect (available in J.M.A. or at simple request). The return of the newsletter signed and accompanied with the corresponding check will draw away the taking into account of inscription as well as approval of the gift regulations by the applicant.

**Article 20 :** Alone the tenured person of reservation will be considered to be exhibitor. No other third person, except the spouse and the children of the exhibitor, will be allowed as accompanist. A request of infringement, duly justified, will however be able to be granted. She will have to be formulated on the newsletter of reservation and will be subjected to the guiding office for approbation. In case of punctual absence during demonstration, the exhibitors will be required to make replace to assure a permanent presence on their stands.

**Article 21 :** Badges or bracelets will be delayed to the exhibitors (1 for a reservation of a table of 1metre and 2 for an equal reservation or superior of 2 meters). They will have the obligation to carry it during all demonstration.

**Article 22 :** In case of force away the abolition of demonstration, the poured funds will be returned at even and without the exhibitor's being not able to exercise an appeal whatever title it belongs against the organizers.

**Article 23 :** **For shows allowing an installation the day before (between 18h to 19h00), alone will be able to achieve the persons having reserved for the rate increased by 5€ the mœer to cover expenses of caretaking and the additional cost of tenancy.**
